## End the Silence. Speak Up and Design a Better Future for Kids in Care.

The number of children and young people removed from families and placed in out-of-home care continues to rise and has now reached 43,339\*. CREATE calls for an end to the silencing of the most vulnerable members of our community – children and young people in care – through external monitoring of the system designed to protect them.

**CREATE urges the community to speak up and give voice to those in care during this federal election month**. CREATE Foundation is the national peak consumer body representing the voices of children and young people with an out-of-home care experience. Independent research has revealed that **if you have a care experience you are more likely to be undereducated, unemployed, become a parent at a younger age, become homeless and be dependent on social assistance.** 

CREATE works to change all this and our three main election priorities are:

- 1. External monitoring and reporting of out-of-home care services, including establishing independent channels to advocate for children and young people in out-of-home-care.
- 2. After-care support available to the age of 25, in every state and territory.
- 3. Priority access to government services for children and young people with a care experience.

Calling for external monitoring and independent complaint mechanisms includes a call for commitment to implementing recommendations from the Royal Commission into Institutional Responses to Child Sexual Abuse, due in 2017.

Recently CREATE hosted a Think Tank with young people with a care experience to identify issues arising from their care experience and transition to independence. From this consultation CREATE and young people call for the following changes:

CREATE has been committed to enabling children and young people to have a voice, direct to those responsible for their care. Since 2009, CREATE's independent consultations with those with a care experience have been a platform to have a voice and to inform positive change in the sector. This external data has revealed the key issues and where support is needed most.

# "CREATE is calling for the next Australian government to show their support and design a better future for kids in care," said Ms Jacqui Reed, Chief Executive CREATE Foundation.

"Young people are the experts on the change that is needed. In Queensland there have been successes where children and young people have taken part in having a say, and together as a community sector, positive change has been implemented through the Next Step service. We know a better future for kids in care is within reach."

CREATE Foundation regularly consults with young people and through this consultation in 2009 revealed a truthful yet somewhat bleak portrait of the reduced life outcomes experienced by children and young people growing up in the care system. The Report Card revealed that if you've been in out of home care, you are more likely to be **undereducated**, **unemployed**, to **earn less**, become a **parent at a younger age**, be involved in the j**uvenile justice** system, become **homeless** and be dependent on **social assistance**.

- 35% are homeless in the first year of leaving care
- 46% of boys are involved in the juvenile justice system
- 35% completed Year 12 (compared to that of the general population)
- 29% are unemployed (compared to the national average which is 9.7%)
- 28% were already parents themselves

CREATE's 2013 Report Card revealed

- 36% of children and young people are split from their brothers and sisters in care
- 31% attend 3 or more primary schools and have greater rates of suspension
- 35% have 5 or more caseworkers during their time in care
- 67% are not aware of any official leaving care plan
