### **About CREATE's Influencing Committee**

The purpose of the Influencing Committee is to bring together CREATE's Policy and Advocacy and Marketing teams to develop and implement key strategies to promote CREATE's advocacy goals.

<u>Two</u> positions are available for young people to join the Influencing Committee. Young people can nominate themselves using the Application Form below and must identify two suitable references (people who can support their application and suitability for the role). The young person's State Coordinator must support the application.

All applications will be considered, and the Influencing Committee Members will shortlist applicants and offer them an opportunity to have a chat about their application through an interview.

Influencing Committee responsibilities will include:

- Attending a monthly Influencing Committee meetings over Zoom if young people are not based in Qld;
- Preparing for meetings by reading the material in advance and discussing any questions (with a member of the Influencing Committee) before the meeting;
- Sharing your opinions, ideas and perspectives about a range of topics related to the National Influencing Strategy and actively participate in the meetings.

#### Eligibility

All applicants need to have the following to be able to apply:

- Be between 15 25 years of age
- Have an out of home care experience
- Be a clubCREATE member and have completed Speak Up Training (SUP) Level 3
- Been an active participant in the state/territory Youth Advisory Groups and state activities
- Willing to commit to being an active Influencing Committee Member for six months
- Willing to engage with other children and young people in care, to adequately represent their views
- Possess good communication skills and is able to work constructively in a group/team.

(If you are under 18 you must discuss your nomination with your parent, guardian, carer or case worker and have them sign the form).

#### Payment

Young people are expected to attend monthly meetings for approximately 1.5 hours. CREATE will cover 2 hours pre-reading and preparation, 2 hours for the meeting day and 1 hour for post meeting follow up = 5 hours per month. This will be reviewed after six months.

CREATE will reimburse young people for their time at the current Youth Facilitator rate of pay (which is slightly different in each state).
