

### Terms and conditions: QFCC Art Showcase, August - November 2023

1. Information on how to enter and prizes form part of these Terms and Conditions. Entry in this promotion is deemed acceptance of these Terms and Conditions.
2. The Promoter is CREATE Foundation (“the Promoter”).
3. Promotion commences at 9.00am AEST 22 August 2023 and closes at Midnight AEST 30 November 2023 (“Promotion Period”). Entries received after the promotion period will not be accepted.
4. Eligible Entrants will be eligible to win vouchers for participating:
  - a. \$25 voucher per entry (for the first 100 entrants).
  - b. There will be up to 5 x \$200 vouchers given to outstanding art entries.
5. To enter the competition Eligible Entrants must:
  - a. Send a photo of their artwork along with their name, age, email and mobile number (optional) by email to [QFCCART@create.org.au](mailto:QFCCART@create.org.au) or submit via the competition section on the CREATE Foundation website, CREATE Instagram or CREATE Facebook.
